**RECOMMENDING THE PROCUREMENT OF OFFICE SUPPLIES FOR PAO
REGIONAL OFFICE NO. IX-B AND ITS DISTRICT OFFICES, UNDER SECTION 52.1
(B), IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 9184, IN
RELATION TO (V) (C) OF ANNEX H OF THE CONSOLIDATED GUIDELINES FOR
THE ALTERNATIVE MODES OF PROCUREMENT.**

WHEREAS, the Public Attorney's Office (PAO) is committed to adhere to its mandate to represent, free of charge, indigents and other persons qualified for legal assistance in all civil, criminal, labor, administrative and other quasi-judicial cases where, after due evaluation, it is determined that the interest of justice will be served thereby;

WHEREAS, it is likewise the thrust of the Public Attorney's Office to extend its services to the marginalized sectors of our society and provide efficient public service to our valued constituents;

WHEREAS, in order to pursue its goals, it is necessary that PAO Regional Office No. IX-B be furnished with Three Hundred Twenty (320) bottles of EPSON Ink Cyan (003), Three Hundred Twenty (320) bottles of EPSON Ink Magenta (003), Three Hundred Twenty (320) bottles of EPSON Ink Yellow (003), and Three Hundred Twenty (320) bottles of EPSON Ink Black (003). Hence this recommendatory resolution;

WHEREAS, considering that the procurement through the DBM-PS is not feasible in view of the unavailability of their supplies, there is thus a need for the immediate purchase of the aforementioned item;

WHEREAS, there is an approved budget for the contract of the subject procurement with a total amount of Three Hundred Ninety-Three Thousand Six Hundred Pesos (P393,600.00);

WHEREAS, the purchase of the aforementioned supplies contemplating of a SHOPPING under Section 52.1(B) of the Implementing Rules and Regulations of Republic Act No. 9184, in relation to No. (V) (C) of Annex "H", Consolidated Guidelines for the Alternative Modes of Procurement, is therefore proper, justified and in order;

NOW THEREFORE, BE IT RESOLVED, that the Members of PAO Bids and Awards Committee, Regional Office IX-B, by virtue of the powers bestowed upon us by law, do hereby recommend the purchase of Three Hundred Twenty (320) bottles of EPSON Ink Cyan (003), Three Hundred Twenty (320) bottles of EPSON Ink Magenta (003), Three Hundred Twenty (320) bottles of EPSON Ink Yellow (003), and Three Hundred Twenty (320) bottles of EPSON Ink Black (003) of PAO Regional Office No.
