RESOLUTION

DECLARING A SECOND FAILURE OF BIDDING IN THE PROCUREMENT OF DELIVERY AND SUPPLY OF DRINKING WATER FOR CY 2021 FOR THE PAO CENTRAL OFFICE

WHEREAS, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

WHEREAS, BAC published on December 12, 2020 a second invitation to bid for the subject procurement in the PhilGEPS under Bid No. 7340568 and posted it in the PAO website and PAO lobby;

WHEREAS, despite second posting of notices and invitation to bid, no bids for the subject procurement were received until the last scheduled of submission of bids;


WHEREAS, Section 35,1(a) of the Revised IRR of R.A.9184 provides that the BAC shall declare the bidding a Failure when no bids are received, BAC Member Atty. Rigel Salvador moved to declare a second failure of bidding for the subject procurement duly seconded by BAC Member Atty. Flordeliza Merelos;

WHEREAS, considering Section 35.2 of the same Act provides that in order to determine the reason for the failed bidding, the committee shall conduct a mandatory review and evaluation of the terms, conditions and specifications in the Bidding Documents including its cost estimates, the PBAC Technical Working Group is advised to prepare its recommendation on the adjustments, if any, on the terms conditions and specifications for the purposes of the conduct of the mandatory review.

NOW THEREFORE, WE, the Members of the PAO Bids and Awards Committee (PBAC), by virtue of the powers vested on Us by Law, after duly considering the recommendations of the Technical Working Group (TWG), and all members here present, **hereby resolve to DECLARE A SECOND FAILURE OF BIDDING FOR THE PROCUREMENT OF SUPPLY AND DELIVERY OF WATER SUPPLY FOR CY 2021 FOR PAO-CENTRAL OFFICE AND TO DIRECT THE PBAC-TWG TO**






