**INVITATION TO BID FOR THE
PROCUREMENT OF BOND PAPERS
(2ND BIDDING)**


1. The *PUBLIC ATTORNEY'S OFFICE (PAO)*, through the *General Appropriations Act (GAA) 2018* intends to apply the sum of *Eight Million, Seven Hundred Forty Nine Thousand, Six Hundred Pesos (Php 8,749,600.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for *the procurement of bond paper supply* as specified in the purchase requests by the PAO-Administrative Service. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *PUBLIC ATTORNEY'S OFFICE (PAO)* now invites bids for *the procurement of Bond Papers, for a minimum of 36,400 reams for 80 gsm, subs. 24, size: 216mm x 330mm (Long) for Six Million, Four Hundred Seventy Nine Thousand, Two Hundred Pesos (P6,479,200.00) and 13,200 reams for 80 gsm, subs. 24, size: 210mm x 297mm (A4), for Two Million, Two Hundred Seventy Thousand, Four Hundred Pesos (P2,270,400.00), both at a maximum total cost of Eight Million, Seven Hundred Forty Nine Thousand, Six Hundred Pesos (Php 8,749,600.00) as herein specified in the pertinent Purchase Request.*
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act", and which is expected to proceed on **20 August 2018**.
4. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184, and the basic eligibility that it already completed a single contract that is similar to this Project, equivalent to at least twenty-five percent (25%) of the ABC or at least the amount of Two Million, One Hundred Eighty Seven Thousand, Four Hundred Pesos (Php 2,187,400.00) for the past thirty six (36) months prior the deadline for the submission and receipt of bids. A Bid Data Sheet (BDS) is included in the Bidding Documents for Reference on the full list of qualifications to bid in this project.
5. Interested bidders may obtain further information from *the PAO Central Office* and inspect the Bidding Documents at the address given below during weekdays *8:00 in the morning until 5:00 in the afternoon, except holidays*.
6. A complete set of Bidding Documents may be acquired by interested Bidders on **18 July 2018 to 06 August 2018** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of *Ten Thousand Pesos (₱ 10,000.00)*.
7. To obtain Bidding Documents in any other means, or any related questions thereto, the same are best inquired upon directly in the information given below.

8. The PUBLIC ATTORNEY'S OFFICE will hold a Pre-Bid Conference on **27 July 2018** at **9:00 A.M. to 10:00 A.M.** at the Office of the Officer-In-Charge of the Fields Operations and Statistics Service (FOSS), which shall be open to prospective and interested parties.
9. Bids must be delivered to the address below on or before **06 August 2018** at 4:30 PM. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the herein attached document certified by the PAO-FPMS.
10. All Bids will be considered valid only until **05 November 2018** or until 90 days from the date of bid opening.
11. Bid opening shall be on **07 August 2018, 9:00 A.M.** at the Office of the Officer-In-Charge of the Fields Operations and Statistics Service (FOSS), 4th Floor DOJ Agencies Building, NIA Road corner East Avenue, Diliman, Quezon City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
