WHEREAS, there is an approved budget for the contract of the subject procurement with a total amount of Ninety Four Thousand Pesos (Php 94,000.00) ${ }^{2}$;

WHEREAS, this committee previously resolved last 13 April 2023 to procure the subject items through Shopping (53.1b);

WHEREAS, after complying with the required posting ${ }^{3}$ of the Request for Quotation (RFQ) for the subject procurement in accordance with the procedure set forth for Shopping under the abovementioned provisions of RA 9184, eleven (11) suppliers responded and submitted their detailed quotations within the scheduled deadline for submission of quotation on 20 April $2023^{4}$;

WHEREAS, after conducting a comparative evaluation of the qualified submitted quotations and their qualifying documents, it appeared that quotation submitted by DAI and Amada Enterprises (AE) were tied as the lowest calculated quotation, both submitting a quotation in the amount of Seventy Two Thousand Pesos (Php72,000.00);

WHEREAS, considering the tie and in accordance with GPPB Circular 06-2005, this committee, after notifying and inviting both DAI and AE , conducted a tie-breaking proceeding thru draw lots, which resulted to DAI drawing the winning lot;

WHEREAS, considering the foregoing, BAC Member Atty. Rigel Salvador moved to award the contract of procurement to DAI for having the lowest calculated and responsive qualified quotation, duly seconded by BAC Member Dir. Marilyn Boongaling;
