The PAO-Bids and Awards Committee issued a resolution dated 13 April 2021 recommending the immediate pursuance of procurement of suitable office space to be leased by the PAO-Roxas, Oriental Mindoro through Negotiated Procurement under Emergency Cases in accordance with Section 53.2 in relation to annex "H" No. V Subsection (D)2-a(i-iii.a) of the IRR of RA 9184 and to delegate to the PAO-Roxas, Oriental Mindoro, in coordination with its Regional Public Attorney, the conduct of the aforementioned negotiated procurement in accordance with Annex "H" No. IV, Subsection (J) of the IRR of RA 9184.

After direct negotiation by the PAO-Roxas, Oriental Mindoro District Office and its evaluation and confirmation of your offer to lease your premises for PAO-Roxas, Oriental Mindoro District Office to address the emergency, a recommendation was made by the subject District Office and its Regional Public Attorney to award the contract for lease of office space from your office. The same recommendation for procurement being approved, you are hereby issued this Notice of Award for the lease of Office Space located in Sta. Fe, Bagumbayan, Roxas, Oriental Mindoro for PAO-Roxas Oriental Mindoro in the amount of One Hundred Forty-four Thousand Pesos (Php 144, 000.00).

**For Negotiated Procurement under Emergency Case for the Lease of Office Space for PAO-Roxas, Oriental Mindoro District Office**



A letter dated 06 April 2021 was sent by the subject District Office, addressed to the Head of the Procuring Entity, regarding its request for the lease of office space citing and detailing the immediate need to provide for a safer office space for PAO lawyers, staffs and clients in consideration of the danger of the continuous rise Covid-19 infections. The PAO-Bids and Awards Committee (PBAC) thereafter issued a resolution dated 13 April 2021 recommending the conduct of negotiated procurement under emergency case in order to immediately address the aforementioned needs of the subject District Office.

Considering the verified existence of real threat to the life and health of the PAO employees and clients brought by a national pandemic as supported Presidential Proclamation 1021 s. 2021, extending the declaration of State of Calamity due to the Corona Virus Disease, the urgent and immediate need to provide for an office space for the PAO-Roxas, Oriental Mindoro District Office is warranted.

It is likewise confirmed that there is a fund in the PAO budget to cover the subject procurement project.
