**RESOLUTION NO. 006 series of 2023**

**RECOMMENDING THE PROCUREMENT OF OFFICE EQUIPMENT FOR AURORA DISTRICT OFFICE OF PAO REGIONAL OFFICE NO. IX-B, UNDER SECTION 53.9, IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 9184, IN RELATION TO (V) (D) (8) OF ANNEX H OF THE CONSOLIDATED GUIDELINES FOR THE ALTERNATIVE MODES OF PROCUREMENT.**

**WHEREAS**, the Public Attorney's Office (PAO) is committed to adhere to its mandate to represent, free of charge, indigents and other persons qualified for legal assistance in all civil, criminal, labor, administrative and other quasi-judicial cases where, after due evaluation, it is determined that the interest of justice will be served thereby;

**WHEREAS**, it is likewise the thrust of the Public Attorney's Office to extend its services to the marginalized sectors of our society and provide efficient public service to our valued constituents;

**WHEREAS**, in order to pursue its goals, it is necessary that Aurora District Office of PAO Regional Office No. IX-B be furnished with Two (2) units of Uninterruptible Power Supply (UPS). Hence this recommendatory resolution;

**WHEREAS**, there is an approved budget for the contract of the subject procurement with a total amount of Twenty-Three Thousand Two Hundred Fourteen Pesos (P23,214.00);

**WHEREAS**, since the pursuit of a competitive bidding will result in the award of the contract relative to the purchase of the mentioned items, only after the lapse of one hundred twenty (120) days from the start of the procurement process, and which period, may not be responsive to the immediate need of the Office;

**WHEREAS**, the purchase of the aforementioned office equipment contemplating of a SMALL VALUE PROCUREMENT (SVP) under Section 53.9 of the Implementing Rules and Regulations of Republic Act No. 9184, in relation to No. (V) (D) (8) of Annex "H", Consolidated Guidelines for the Alternative Modes of Procurement, is therefore proper, justified and in order;

**NOW THEREFORE, BE IT RESOLVED**, that the Members of PAO Bids and Awards Committee, Regional Office IX-B, by virtue of the powers bestowed upon us by law, do hereby recommend the purchase of Two (2) units of Uninterruptible Power Supply (UPS) for Aurora District Office of PAO Regional Office No. IX-B, under Small Value Procurement (SP) pursuant to Section 53-9 of the Implementing Rules and Regulations of Republic Act No. 9184 in relation to No. (V) (D) (8) Annex "H".


