RESOLUTION

DIRECTING THE PAO-BAC TECHNICAL WORKING GROUP (PBAC-TWG) TO PREPARE A REPORT AND RECOMMENDATION ON THE SPECIFIC ADJUSTMENTS ON THE TERMS, CONDITION AND SPECIFICATIONS, INCLUDING COST ESTIMATES FOR THE NEGOTIATED PROCUREMENT OF DELIVERY AND SUPPLY OF DRINKING WATER FOR CY 2021 UNDER PURCHASE REQUEST NO. 547-10-2020, FOR THE PAO CENTRAL OFFICE

WHEREAS, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;


WHEREAS, this committee previously issued a resolution dated 12 January 2021 for the conduct of second invitation for submission of proposals for purposes of negotiation for the procurement of delivery and supply of drinking water under the provisions for negotiated procurement under Section 53.1 of the IRR of R.A. 9184;

WHEREAS, despite postings and sending out of invitations to submit proposals for subject negotiated procurement to at least three (3) suppliers, no proposals were received until today's meeting;

WHEREAS, BAC Member Atty. Rigel Salvador moved to direct the PBAC-TWG to prepare a report and recommendation on the specific adjustments needed on the terms, conditions and specifications, including its cost estimates for the subject procurement to be submitted on 21 January for purposes of the conduct of mandatory review in accordance with Annex "H" No. V Subsection (D) 1.b of the revised implementing rules and regulation of R.A. 9184, duly seconded by BAC Member Atty. Flordeliza Merelos;

NOW THEREFORE, WE, the Members of the PAO Bids and Awards Committee (PBAC), by virtue of the powers vested on Us by Law, after duly considering the recommendations of the Technical Working Group (TWG), and all members here present, **hereby resolve to DIRECT THE PAO-BAC TECHNICAL WORKING GROUP (PBAC-TWG) TO PREPARE A REPORT AND RECOMMENDATION ON THE SPECIFIC ADJUSTMENTS ON THE TERMS, CONDITION AND SPECIFICATIONS, INCLUDING COST ESTIMATES FOR PURPOSES OF MANDATORY REVIEW FOR THE NEGOTIATED PROCUREMENT OF DELIVERY AND SUPPLY OF DRINKING WATER FOR CY 2021 UNDER PURCHASE REQUEST NO. 547-10-2020, FOR THE PAO CENTRAL OFFICE, IN ACCORDANCE WITH ANNEX "H" No. V SUBSECTION (D) 1.b OF THE IRR OF R.A.
