**RECOMMENDING THE EXTENSION OF PERIOD FOR THE POST-QUALIFICATION OF THE SUBMITTED BIDS IN THE PROCUREMENT OF 500 MS OFFICE LICENSE AS SPECIFIED UNDER PURCHASE REQUEST NO. 646-07-2022 FOR THE PAO-CENTRAL OFFICE FOR C.Y. 2022**

**WHEREAS**, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

**WHEREAS**, this committee previously resolved to declare the submitted bid of Infoworx, Inc. (INFOWORX) as the Lowest Calculated Bidder, subject to post-qualification, among the nine (9) submitted bids from the following suppliers namely: (QUARTZ); World Solution Technology, Inc. (WORLD); Unison Computer Systems Inc. (UNISON) Pronet Systems Integrated Network Solutions, Inc, (PRONET); Joneco Tech Marketing Corp. (JONECO); Advance Solutions, Inc. (ASI); Infoworx, Inc. (INFOWORX) and Radenta Technologies Inc. (RADENTA);


**WHEREAS**, upon the conduct of post-qualification by the PAO-BAC Technical Working Group (TWG), it appears that there is a discrepancy in the technical requirements submitted by INFOWORX along with the rest of the submitted bids that requires additional time for thorough evaluation;

**WHEREAS**, considering the foregoing, BAC Member Dir. Marilyn Boongaling moved to recommend to the Head of Procuring Entity the extension of period of post-qualification by seven (7) days from today as allowed in accordance with Sec. 34.5 Rule X of the Revised Implementing Rules and Regulations of Republic Act No. 9184, duly seconded by BAC Member Atty. Alem Abeya;


