EXCERPTS FROM THE MINUTES OF THE MEETING OF THE PAO BIDS AND AWARDS COMMITTEE (PBAC) DATED 29 JULY 2021 RE: RESULT OF EVALUATION OF SUBMITTED BIDS FOR THE PROCUREMENT OF ICT EQUIPMENT FOR PAO LAN INFRASTRUCTURE PROJECT UNDER PURCHASE REQUEST NO. 492-06-2021, HELD AT THE PAO-LIBRARY, PAO CENTRAL OFFICE AND VIA ZOOM VIDEO CALL

**RESOLUTION**

**DECLARING THE SUBMITTED BID OF QUARTZ BUSINESS CORPORATION (QUARTZ) FOR LOTS 1 and 3; AND ACCEL PRIME TECHNOLOGIES, INC. (ACPTI), FOR LOT 2, AS THE LOWEST CALCULATED BID, SUBJECT TO POST-QUALIFICATION, WITH A FAILURE OF BIDDING FOR LOT 4 IN THE PROCUREMENT OF INFORMATIN AND COMMUNICATION TECHNOLOGY (ICT) EQUIPMENT FOR THE IMPLEMENTATION OF THE PUBLIC ATTORNEY'S OFFICE (PAO) LAN INFRASTRUCTURE PROJECY (PAO ICT-LAN) UNDER PURCHASE NO. 492-06-2021**

**WHEREAS**, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

**WHEREAS**, PAO posted on 06 July 2021 an invitation to bid for the subject procurement in the PhilGEPS under Reference No. 7822226 and posted in the PAO website and PAO lobby;

**WHEREAS**, PAO held a pre-bid conference for the subject procurement attended by suppliers/bidders last 16 July 2021;

**WHEREAS**, there is an approved budget for the contract of the subject procurement amounting to: LOT 1: Php 8,309,400.00; LOT 2: Php 3,603,600.00; LOT 3 Php 7,771,800; and LOT 4 P90,000.00;

**WHEREAS**, five (5) bidders namely: Accel Prime Technologies, Inc. (APTI); Commsource Systems and Ingtegrated Solutions, Inc. (COMMSOURCE); Delsan Office Systems Corp. (DELSAN); Integrated Computer Systems (ICS) and Quartz Business Products Corporation (QUARTZ) submitted their bids before the scheduled deadline of submission;

**WHEREAS**, after due notice given to the Commission on Audit, independent observers and to the bidders, this committee opened the sealed bids on the

scheduled day of its opening and thoroughly evaluated its contents<sup>1</sup>, in the presence of all the bidders via Zoom video conference call;

**WHEREAS**, after evaluating the remaining submitted bids, it appears that, QUARTZ submitted the lowest bid price for Lot 1 in the amount of P6,220,585.00 and in Lot 3 in the amount of P3,053,787.00 while APTI submitted the lowest bid price for Lot 2 in the amount of P2,688,000.00 with no received bids for Lot 4;


**WHEREAS**, Section 35.1 (a) of the Revised IRR of R.A. 9184 provides that the BAC shall declare the bidding a failure when no bids are received;

**WHEREAS**, Section 35.2 of the same Act provides that in order to determine the reason for the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms, conditions and specifications in the Bidding Documents, including its cost estimates;

**WHEREAS**, considering the aforementioned submitted bid prices for Lots 1 to 3 and that no bids were submitted for Lot 4, BAC Member Atty. Alem Abeya moved to declare the bid of QUARTZ as the Lowest Calculated Bid for Lot 1 and Lot 3 while declaring the bid of APTI as the Lowest Calculated Bid for Lot 2, subject to post-qualification check by the PAO-BAC Technical Working Group (PBAC-TWG); and to declare a failure of bidding for Lot 4 with order for a mandatory review by the PBAC-TWG, duly seconded by BAC Member Atty. Rigel Salvador;

**NOW THEREFORE, WE**, the Members of the PAO Bids and Awards Committee (PBAC), by virtue of the powers vested on Us by Law, after duly considering the recommendations of the Technical Working Group (TWG), and all members here present, **hereby resolve to DECLARE THE SUBMITTED BID OF QUARTZ BUSINESS CORPORATION (QUARTZ) FOR LOTS 1 and 3; AND ACCEL PRIME TECHNOLOGIES, INC. (ACPTI), FOR LOT 2, AS THE LOWEST CALCULATED BID, SUBJECT TO POST-QUALIFICATION FOR THE CONSIDERATION OF THE BAC AND TO DECLARE A FAILURE OF BIDDING WITH ORDER FOR CONDUCT OF MANDATORY REVIEW BY THE PBAC-TWG FOR LOT 4 IN THE PROCUREMENT OF INFORMATION AND COMMUNICATION TECHNOLOGY (ICT) EQUIPMENT FOR THE IMPLEMENTATION OF THE PUBLIC ATTORNEY'S OFFICE (PAO) LAN INFRASTRUCTURE PROJECY (PAO ICT-LAN) UNDER PURCHASE NO. 492-06-2021.**
