#### RESOLUTION

RECOMMENDING THE DELEGATION OF THE AUTHORITY TO CONDUCT THE PROCUREMENT OF OFFICE SPACE RENTAL FOR PAO-ANTIPOLO CITY DISTRICT OFFICE, UNDER PURCHASE REQUEST NO. 370-04-2023, TO ITS CONCERNING PAO DISTRICT OFFICER-IN-CHARGE, PURSUANT TO ANNEX "H," NO. IV, SUBSECTION (J) OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT NO. (RA) 9184.

**WHEREAS,** the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

**WHEREAS**, PAO-Antipolo City District Office, sent a letter<sup>1</sup> to the Chief Public Attorney requesting for a new office space for its District Office for June 2023 to December 2023;

**WHEREAS**, there is an approved budget for the contract of the subject procurement with a total amount of One Hundred Seventy Five Thousand Pesos (Php 175,000.00)<sup>2</sup>;

WHEREAS, in order to ensure the unhampered service of PAO Antipolo City District Office and to streamline its request for a new office space, this committee recommends to the Head of Procuring Entity the delegation of authority to conduct its procurement to its concerning PAO District Officer-in-Charge;

**WHEREAS**, considering the foregoing, BAC Member Dir. Marilyn Boongaling moved for the delegation of the authority to process and conduct procurement of lease of real property and venue for the subject PAO District Office to its concerning PAO-District Officer-in-Charge in accordance with Annex "H" No. IV Subsection (J) of the IRR of RA 9184, duly seconded by BAC Member Atty. Rigel Salvador;
