RESOLUTION

RECOMMENDING THE CANCELLATION OF THE DELEGATED CONDUCT OF SMALL VALUE PROCUREMENT FOR THE PROCUREMENT OF SUPPLY AND INSTALLATION OF WINDOW BLINDS AS SPECIFIED UNDER PURCHASE REQUEST NO. 589-07-2023, FOR PAO-MANILA DISTRICT OFFICE

WHEREAS, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

WHEREAS, this committee previously resolved¹ to recommend the conduct of delegated Small Value Procurement of Window Blinds for PAO Manila District Office under Purchase Request No. 589-07-2023;

WHEREAS, there was an approved budget for the contract of the subject procurement with a total amount of Thirty Five Thousand Pesos (Php 35,000.00)²;

WHEREAS, the PAO-Supply Section informed this committee that there is a discrepancy between the provided technical specifications on the measurements for the subject procurement that would make the purchase of the subject window blinds unusable;

WHEREAS, after consultation with the PAO-Supply Section and the Technical Working Group (TWG), said discrepancy in the technical specifications was confirmed;

WHEREAS, in line with the declared policy of RA 9184 in promoting good governance by adhering with principles of transparency, accountability, equity, efficiency and economy, it appears that there is a need to cancel the subject procurement until conduct and confirmation of correct measurements to be reflected in a new Terms of Reference from the TWG;

WHEREAS, considering the foregoing, BAC Member Atty. Ronald Macorol moved to recommend the cancellation of the subject procurement and to order the TWG to submit a new Terms of Reference containing correct specification for the subject procurement, duly seconded by BAC Member Dir. Marilyn Boongaling;

NOW THEREFORE, WE, the Members of the PAO Bids and Awards Committee (PBAC), by virtue of the powers vested on Us by Law, after duly considering the recommendations of the Technical Working Group (TWG), and all members here present, hereby resolve to recommend to the Head of Procuring Entity to CANCEL THE DELEGATED CONDUCT OF SMALL VALUE PROCUREMENT FOR THE


