(CENTER) IN THE PROCUREMENT OF VARIOUS OFFICE SUPPLIES AS SPECIFIED UNDER PURCHASE REQUESTS NO. 613-07-2023, HELD AT THE PAOLIBRARY, PAO CENTRAL OFFICE AND VIA ZOOM VIDEO CALL

### RESOLUTION

RECOMMENDING THE EXTENSION OF PERIOD FOR THE POST-QUALIFICATION OF THE SUBMITTED BIDS OF CENTER POINT SALES & TRADING, INC. (CENTER) IN THE PROCUREMENT OF VARIOUS OFFICE SUPPLIES AS SPECIFIED UNDER PURCHASE REQUEST NO. 613-07-2023 FOR THE PAO-CENTRAL OFFICE FOR C.Y. 2023

**WHEREAS,** the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

**WHEREAS,** after the conduct of several pre-procurement conferences, PAO posted on 07 September 2023 an invitation to bid for the subject procurement in the PhilGEPS under Reference No. 10112151 and likewise posted in the PAO website and PAO lobby;

**WHEREAS,** PAO held a pre-bid conference for the subject procurement attended by suppliers/bidders last 21 September 2023;

**WHEREAS**, there is an approved budget for the contract of the subject procurement amounting to Six Million One Hundred Nine Thousand and Five Hundred Pesos (P6,109,000.00);

**WHEREAS,** this committee previously resolved last 05 October 2023 to declare the submitted bid of Center Point Sales & Trading, Inc. (CENTER) as the Single Calculated Bidder, subject to post-qualification;

**WHEREAS,** on 13 October 2023, upon the conduct of post-qualification by the PAO-BAC Technical Working Group (TWG), they noted that CENTER haven't submitted their Distributor's Certification and that two (2) of the sample items submitted by CENTER did not pass the quality set by the TWG despite giving them sample of the products the agency was currently using;

**WHEREAS**, CENTER through the TWG requested to this committee that the post-qualification conference be continued on 16 October 2023 to grant CENTER

additional time to submit another sample of their product as well as to submit their pending document;

**WHEREAS**, on 16 October 2023, the TWG reported that CENTER was able to submit their Distributor's Certificate and the sample items, but upon checking one of which (white mailing envelope) still remains unsatisfactory to their quality standards;

**WHEREAS**, the CENTER sent a letter<sup>1</sup> to this committee through email requesting for an additional period of until 20 October 2023 to resubmit another sample of the item;

**WHEREAS**, considering the foregoing, BAC Member Dir. Marilyn Boongaling moved to recommend to the Head of Procuring Entity the extension of period of post-qualification until 20 October 2023, as allowed in accordance with Sec. 34 Rule X of the Revised Implementing Rules and Regulations of Republic Act No. 9184, duly seconded by BAC Member Atty. Alem Abeya;

NOW THEREFORE, WE, the Members of the PAO Bids and Awards Committee (PBAC), by virtue of the powers vested on Us by Law, after duly considering the recommendations of the Technical Working Group (TWG), and all members here present, hereby resolve to RECOMMEND TO THE HEAD OF PROCURING ENTITY THE EXTENSION OF PERIOD FOR POST-QUALIFICATION OF SUBMITTED BIDS OF CENTER UNTIL ON OR BEFORE 20 OCTOBER 2023, IN ACCORDANCE WITH THE SEC. 34 RULE X OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF RA 9184.
