RESOLUTION

RECOMMENDING THE PROCUREMENT THROUGH DIRECT CONTRACTING OF TWO **HUNDRED (200) UNITS OF KYOCERA TK-6113 TONERS FOR COPIER MODEL ECOSYS** M4125IDN, AS SPECIFIED UNDER PURCHASE REQUEST NO. 760-09-2023, FOR PAO-CENTRAL OFFICE, SUPPLY SECTION UNDER SECTION 50(c) IN RELATION TO ANNEX "H," NO. V, SUBSECTION (A)1-c OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT NO. (RA) 9184

WHEREAS, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

WHEREAS, considering that the use of photocopiers and its corresponding parts is crucial in the day-to-day discharge of functions in this Office in view of the voluminous cases it handles both in the judicial and non-judicial services it caters;

WHEREAS, in view of the fact that the subject machines of the requesting PAO Office are in need of replacement parts and must all be immediately repaired in order not to hamper the service delivery of the Offices;

WHEREAS, since the parts needed to be replaced/repaired are exclusively¹ provided by Philcopy Corporation (Philcopy) and the needed parts are critical components of the copiers, it is but proper that the same be immediately procured from the said entity;

WHEREAS, there is an approved budget for the contract of the subject procurement with a total amount of One Million Nine Hundred Forty Thousand Pesos (Php 1,940,000.00)²;

WHEREAS, ultimately considering that the procurement of the mentioned items are exclusively distributed by PHILCOPY as evidenced by their submitted Certifications stating among others that they are the exclusive distributor of the items subject of the procurement and that there are no sub-dealers selling at lower prices and for which no substitute can be obtained at more advantageous terms to the government as likewise confirmed by PAO BAC Technical Working Group (TWG) and PAO-Supply Section during this meeting including the fact that that the said distributor has the proper qualifications as supplier of the subject procurement in accordance with the law, BAC Member Atty. 




