RESOLUTION

RECOMMENDING THE AUTHORIZATION FOR THE CORRECTION OF PHILGEPS ENTRY FOR AWARD NOTICE ABSTRACT NO. 4036683 UNDER PHILGEPS REFERENCE NO. 9224103, INVOLVING THE NAME OF AWARDEE AND CONTRACT AMOUNT, AMONG OTHERS, FOR THE PROCUREMENT OF INSPECTION, TESTING AND MAINTENANCE OF PAO AUTOMATIC SPRINKLER SYSTEM FOR CY 2023 UNDER PURCHASE REQUEST NO. 784-08-2022,

WHEREAS, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

WHEREAS, it has come to the attention of this Committee that there has been a discrepancy in the recorded details of Award Notice Abstract for Award Notice No. 4036683 under Philgeps Reference No. 9224103 for the procurement of Fire Sprinkler and Fire Pump System under Purchase Request No. 784-08-2022;

WHEREAS, M.P.M. Safety Industries, Co. was previously issued a Notice of Award for the delegated small value procurement with a contract price of One Hundred Seventy Thousand Pesos (Php 170,000.00)¹ from an ABC of Two Hundred Thousand Pesos (Php 200,000.00);

WHEREAS, upon verification of records, it appears that a former member of the BAC Secretariat created the Philgeps posting for the subject procurement and made the Award Notice Abstract, which unfortunately indicated a different name of awardee and different contract amount, allegedly due to unintended oversight and confusion with another procurement conducted and posted in the Philgeps;

WHEREAS, considering the aforementioned discrepancies and conduct of verification of correct details based on Office records, BAC Member Atty. Ronald Macorol moved to recommend the authorization for the correction of the aforementioned entries in the Philgeps to reflect the correct details of the aforementioned awardee and contract amount, duly seconded by BAC Member Dir. Marilyn Boongaling;

NOW THEREFORE, WE, the Members of the PAO Bids and Awards Committee (PBAC), by virtue of the powers vested on Us by Law, after duly considering the recommendations of the Technical Working Group (TWG), HEREBY RESOLVE TO RECOMMEND TO THE HEAD OF THE PROCURING ENTITY, THE CORRECTION
