RECOMMENDING THE DELEGATION OF THE AUTHORITY TO CONDUCT THE NEGOTIATED PROCUREMENT OF LEASE OF OFFICE SPACE FOR PAOMIMAROPA REGION, PINAMALAYAN OCCIDENTAL MINDORO DISTRICT OFFICE FOR C.Y. 2024, UNDER PURCHASE REQUEST NO. 986-12-2023, TO ITS CONCERNING REGIONAL PUBLIC ATTORNEY'S OFFICE IN COORDINATION WITH THE DISTRICT OFFICE END-USER UNIT, PURSUANT TO ANNEX "H," NO. IV, SUBSECTION (J) IN RELATION TO ANNEX "H". NO. V, SUBSECTION (D) 9 OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT NO. (RA) 9184.

WHEREAS, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

WHEREAS, PAO-Pinamalayan District Office sent a letter dated 23 November 2023 addressed to the Chief Public Attorney through its Regional Public Attorney for the MIMAROPA Region, requesting for lease of office space for its aforementioned District Office for C.Y. 2024;

WHEREAS, there is an approved budget for the contract of the subject procurement with a total amount of Two Hundred Thirty Nine Thousand and Four Hundred Pesos (Php 239,400.00)¹

WHEREAS, in order to ensure the unhampered service of said District Office and to streamline its request for lease of its office space, BAC member Atty. Ronald Macorol recommends to the Head of Procuring entity the delegation of authority to conduct the negotiated procurement to its concerning Regional Public Attorney in coordination with the District Office End-User, in accordance with Annex "H" No. IV Subsection (J) in relation to Annex "H" No. V Subsection (D) 9 of the IRR of RA 9184, duly seconded by BAC Member Dir. Marilyn Boongaling with the other BAC members;



Peace be with you!

We would like to express again our gratitude for allowing the Pinamalayan, Oriental Mindoro District Office to rent our office space. The transfer to the new office invigorates us to work even harder as it is now more comfortable compared to when we were in the Hall of Justice. After almost four (4) years, the Contract of Lease is due for renewal on January 1, 2024.

Relative to this, may we respectfully request that we be allowed to renew the Contract of Lease for another year or longer, if allowable under the circumstances.

The renewal of the Contract is being sought as the Office's location is now familiar with our clients. Transferring to another location would create confusion among our clients as to the location of our office. Also, the Office is within the 300-meter radius from the Hall of Justice (Regional Trial Courts) and our former office which make the office accessible to clients and courts.

The terms and conditions of the new Contract of Lease would still be the same from the previous contract except as to rental which now has a 5% increase from the previous one. The rent is now P19,950.00 monthly; the water will be free as they have their own water system; and two (2) months security deposit to answer for damages to the space and unpaid bills at the end of the contract, if any.

We are hoping for the approval of this request.

CERTIFICATION (WITH COST-BENEFIT ANALYSIS)

The Pinamalayan Oriental Mindoro District Office is located at A and G Building, Mambil Street, Sto. Niño Subdivision, Barangay Marfrancisco, Pinamalayan, Oriental Mindoro. It meets the minimum requirements of the agency and it is more comfortable and presentable to both clients and personnel. The office can comfortably accommodate at least five (5) lawyers and two (2) staff and a good number of clients all at the same time. It is a breath of fresh air from a decade long congestion and cramped office condition of the District when it was still housed at the Hall of Justice.

The office has four (4) cubicles for four (4) lawyers, one (1) stock room which can also be used as an office or cubicle for a lawyer and it has ample space for at least two (2) staff. It has a waiting area for clients which can accommodate five (5) to seven (7) clients. The lawyer's cubicle can accommodate three (3) to five (5) clients. The office has a provision for storage area, comfort room and a modest pantry area.

The office has an area of 60 sq. meters with provision for car parking. It is within the radius of 300 meters from the Hall of Justice which houses the Regional Trial Court Branch 41 and Branch 42, the Provincial Prosecution Office and Parole and Probation Office.

The benefits of renting the office space outweighs the cost. The location of the office is the nearest to the Hall of Justice among all other spaces for rent. As the Office is not located in a commercial area, the rent is lower compared to other available office space for rent, which is farther from the Hall of Justice. The agency's rent of Nineteen thousand nine hundred fifty pesos (Php19,950.00) every month is worth the value of its budget. The Office is accessible to telephone and internet connection; it is located on the ground floor of the building making it more accessible to Persons with Disability (PWD), senior citizens and pregnant women clients. The Tricycle Operator's and Driver's Association (TODA) terminal is just 10 to 15 meters away from the office making it accessible to public transportation.

As the office has a bigger space compared to the previous office in the Hall of Justice, the lawyers and staff work more comfortably which translates to a better service to its clients, in particular and the public in general.

Issued this 23rd day of November, 2023 in Pinamalayan, Oriental Mindoro for whatever legal purpose it may serve.
