RECOMMENDING THE DELEGATION OF THE AUTHORITY TO CONDUCT THE NEGOTIATED PROCUREMENT OF LEASE OF OFFICE SPACE FOR PAOMIMAROPA REGION, ROXAS ORIENTAL MINDORO DISTRICT OFFICE FOR C.Y. 2024, UNDER PURCHASE REQUEST NO. 988-12-2023, TO ITS CONCERNING REGIONAL PUBLIC ATTORNEY'S OFFICE IN COORDINATION WITH THE DISTRICT OFFICE END-USER UNIT, PURSUANT TO ANNEX "H," NO. IV, SUBSECTION (J) IN RELATION TO ANNEX "H". NO. V, SUBSECTION (D) 9 OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT NO. (RA) 9184.

WHEREAS, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

WHEREAS, PAO-Roxas, Oriental Mindoro District Office sent a letter dated 24 November 2023 addressed to the Chief Public Attorney through its Regional Public Attorney for the MIMAROPA Region, requesting for lease of office space for its aforementioned District Office for C.Y. 2024;

WHEREAS, there is an approved budget for the contract of the subject procurement with a total amount of One Hundred Forty Four Thousand Pesos (Php 144,000.00)¹

WHEREAS, in order to ensure the unhampered service of said District Office and to streamline its request for lease of its office space, BAC member Atty. Ronald Macorol recommends to the Head of Procuring entity the delegation of authority to conduct the negotiated procurement to its concerning Regional Public Attorney in coordination with the District Office End-User Unit, in accordance with Annex "H" No. IV Subsection (J) in relation to Annex "H" No. V Subsection (D) 9 of the IRR of RA 9184, duly seconded by BAC Member Dir. Marilyn Boongaling with the other BAC members;





CERTIFICATION (WITH COST-BENEFIT ANALYSIS)

The new office space of Roxas Oriental Mindoro District Office is located at No. 179, Sta. Fe, Bagumbayan, Roxas, Oriental Mindoro. The new office space meets the primary reason for seeking transfer from the old office space, that is: provision of clean comfort room and wash area.

The office can adequately accommodate all the lawyers and staff of the district office and a good number of clients all at the same time. Although now separately located at the primary municipal buildings, the new office space very satisfactorily answered all the problematic aspects of the old office space.

The office has been subdivided into five (5) workstations for at least five (5) employees. It has good lighting and ventilation. It has an adequate waiting area which can cater up to eight (8) to ten (10) clients at the same time. A receiving area is designated for client's concerns, including but not limited to follow-up of clients and legal counselling. There is a designated mediation area. It has an adequate provision for storage of files, several supplies and other unserviceable equipment and furniture.

The office has an area of more or less 100 sq. meters with car ports. It is within the radius of 500 meters from the Regional Trial Court, Municipal Trial Court, the Office of the Provincial Prosecution and the Philippine Post Office.

The benefits of staying at the same office space being leased outweighs the cost. The location of the office is reasonably within the bounds of the main municipal offices. The location of the Office is not located in a commercial area, hence, the rent is much lower as compared to other lessors. The agency's rent of twelve thousand pesos (Php 12,000.00) every month is worth the value of its budget. The office space is accessible to basic municipal services, such as telephone and internet connection. The office basically consisted of one ground floor and a mezzanine where supplies and other non-serviceable equipment are stored. The main receiving area is located on the ground floor making it more PWD, senior citizen and pregnant women compliant. The location is near the roadside, hence, it is easily discoverable and accessible by PAO clienteles. "Pedicab" is always available as means of going to and from the office.

Verily, the current office space is beneficial in aiding the proper disposition of our legal mandates. Also, no offer from the LGu of Roxas or any of the municipalities

covered by the district office is being received. Apart from serving our clients well, the current office space created a new breathable and spacious office space necessary for the welfare and health of every employee. Following Maslow's hierarchy of needs, when the primary needs are addressed, the more the person becomes efficient and always ready to be of service.

Issued this 24th of November 2023 at Roxas, Oriental Mindoro for whatever legal purpose it may serve.
