### RESOLUTION

DECLARING THE SUBMITTED BID OF ACCESSORIES AND SUPPLIES DEPOT INC. (ASDI), AS THE LOWEST CALCULATED AND RESPONSIVE BID FOR LOT 1, AND ADECS INTERNATIONAL CORP. (ADECS) AS THE SINGLE CALCULATED AND RESPONSIVE BID FOR LOT 2, BOTH SUBJECT TO POST-QUALIFICATION, IN THE PROCUREMENT OF VARIOUS INK CARTRIDGES AS SPECIFIED UNDER PURCHASE REQUEST NO. 087-01-2023 FOR THE PAOCENTRAL OFFICE FOR C.Y. 2023

**WHEREAS,** the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

**WHEREAS,** after the conduct of several pre-procurement conferences, PAO published on 16 February 2023 an invitation to bid for the subject procurement in the PhilGEPS under Reference No. 9487631 and posted in the PAO website and PAO lobby;

WHEREAS, PAO held a pre-bid conference for the subject procurement attended by suppliers/bidders last 28 February 2023;

**WHEREAS**, there is an approved budget for the contract of the subject procurement amounting to One Million Six Hundred Ten Thousand Pesos (Php 1,610,000.00) for LOT 1 and Three Millions Six Hundred Thousand Pesos (Php 3,600,000.00) for LOT 2;

**WHEREAS,** three (3) bidders namely: ADECS International Corp (ADECS); DELSAN Office Systems Corporation (DELSAN) and Accessories and Supplies Depot, Inc. (ASDI) submitted their bids for LOT 1 before the scheduled deadline of submission;

WHEREAS, only ADECS International Corp (ADECS) submitted a bid for LOT 2;

WHEREAS, after due notice given to the Commission on Audit, independent observers and to the bidders, this committee opened the sealed bids on the

scheduled day of its opening and thoroughly evaluated its contents, in the presence of all the bidders via Zoom video conference call;

**WHEREAS**, after evaluating the submitted bids<sup>1</sup>, it appears that ASDI submitted the lowest bid price in the amount of One Million Four Hundred Ninety Thousand and Five Hundred Eighty Pesos (P1,490,580.00) for LOT 1, while ADECS submitted a bid price in the amount of Three Million Four Hundred Fifty Five Thousand and Five Hundred Pesos (P3,455,500.00) for LOT 2;

**WHEREAS,** after the evaluation of the submitted bids, BAC Member Dir. Marilyn Boongaling moved to declare the bid of ASDI as the Lowest Calculated Responsive Bid for LOT 1 and ADECS as the Single Calculated and Responsive Bid for LOT 2, both subject to post-qualification, duly seconded by BAC Member Atty. Ronald Macorol;

NOW THEREFORE, WE, the Members of the PAO Bids and Awards Committee (PBAC), by virtue of the powers vested on Us by Law, after duly considering the recommendations of the Technical Working Group (TWG), and all members here present, hereby resolve to DECLARE THE SUBMITTED BID OF ACCESSORIES AND SUPPLIES DEPOT INC. (ASDI), AS THE LOWEST CALCULATED AND RESPONSIVE BID FOR LOT 1 AND THE SUBMITTED BID OF ADECS INTERNATIONAL CORP. (ADECS) AS THE SINGLE CALCULATED AND RESPONSIVE BID FOR LOT 2, SUBJECT TO POST-QUALIFICATION, IN THE PROCUREMENT OF VARIOUS INK CARTRIDGES AS SPECIFIED UNDER PURCHASE REQUEST NO. 087-01-2023 FOR THE PAO-CENTRAL OFFICE FOR C.Y. 2023. FURTHERMORE, THE PBAC TECHNICAL WORKING GROUP (TWG) IS DIRECTED TO VERIFY THE COMPLIANCE, AUTHENTICITY AND VALIDITY OF THE DOCUMENTS SUBMITTED AND REQUIRED FOR PURPOSES OF POST-QUALIFICATION AND TO SUBMIT ITS POST-QUALIFICATION REPORT FOR THE CONSIDERATION OF THE PAO-BAC.




