RESOLUTION

RECOMMENDING THE AMENDMENT OF THE PERIOD COVERED AND APPROVED BUDGET FOR CONTRACT IN THE SMALL VALUE PROCUREMENT OF COMPREHENSIVE PEST AND TERMITE CONTROL SERVICES FOR CY 2023 UNDER PURCHASE REQUEST NO. 785-08-2022

WHEREAS, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

WHEREAS, this committee previously resolved to delegate to PAO-Supply Section the Small Value Procurement of the Comprehensive Termite Control Services of the PAO Central office for CY 2023 under Purchase Request no. 785-08-2022;

WHEREAS, there was previously an approved budget for the contract of the subject procurement with a total amount of Sixty Thousand Pesos (Php 60,000.00)¹;

WHERAS, after posting and issuing a request for quotation for the aforementioned procurement, a Notice of Award was given to Power House Pest Control Service as the lowest submitted quotation with a quotation price in the amount of Thirty-Seven Thousand Seven Hundred Seventy Pesos (Php37,770.00)

WHEREAS, this committee was informed that there was a delay in the release of the purchase order for the aforementioned procurement;

WHEREAS, after due deliberation with the Technical Working Group and coordination with the PAO-FPMS, BAC Member Dir. Marilyn Boongaling moved to amend to adjust the coverage period of the aforementioned pest control services to March to December 2023 and request the supplier with the lowest quotation to reduce its service price accordingly, with a corresponding adjustment of the ABC to Fifty Thousand Pesos (Php50,000.00) from the initial ABC of Sixty Thousand Pesos (Php60,000.00), duly seconded by BAC Member Atty. Ronald Macorol;

NOW THEREFORE, WE, the Members of the PAO Bids and Awards Committee (PBAC), by virtue of the powers vested on Us by Law, after duly considering the recommendations of the Technical Working Group (TWG) and PAO-FPMS, HEREBY RESOLVE TO RECOMMEND TO THE HEAD OF THE PROCURING ENTITY THE AMENDMENT OF THE PERIOD COVERED TO MARCH TO DECEMBER 2023
