**RESOLUTION**

**RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF THE SUPPLY AND INSTALLATION OF FLOOR MOUNTED AIR-CONDITIONING UNIT AS SPECIFIED UNDER PURCHASE REQUEST NO. 832-07-2018 FOR THE USE OF PUBLIC ATTORNEY'S OFFICE-CALOOCAN CITY DISTRICT OFFICE, THROUGH SMALL VALUE PROCUREMENT (SVP) UNDER SECTION 53.9 IN RELATION TO ANNEX "H," NO. V, SUBSECTION (D)8-a OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT NO. (RA) 9184**

**WHEREAS**, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

**WHEREAS**, after complying with the required posting<sup>1</sup> of the Request for Quotation (RFQ) for the subject procurement in accordance with the procedure set forth for SVP under the abovementioned provisions of RA 9184, two suppliers responded and submitted their detailed quotations;

**WHEREAS**, after conducting a comparative evaluation of their submitted quotations, this committee evaluated<sup>2</sup> that the quotation submitted by Super-Aire exceeded the approve budget for the contract (ABC) while the submitted quotation by Abenson is found to be responsive and within the amount set for ABC;

**WHEREAS**, considering the foregoing, BAC Member Atty. Demiteer Huerta moved to disqualify the quotation submitted by Super-Aire and award the contract of procurement to Abenson/Entropy for having the lowest calculated and responsive quotation, subject to post-qualification under Section 39 of RA 9184, duly seconded by BAC Member Atty. Mariel Baja;

**NOW THEREFORE, WE**, the Members of the PAO Bids and Awards Committee (PBAC), by virtue of the powers vested on Us by Law, after duly considering the recommendations of the Technical Working Group (TWG), and all members here present, **hereby resolve to recommend to the Head of Procuring Entity to AWARD THE CONTRACT FOR THE PROCUREMENT OF SUPPLY AND INSTALLATION OF ONE (1) FLOOR MOUNTED AIR-CONDITIONING UNIT AS SPECIFIED UNDER PURCHASE REQUEST NO. 832-07-2018 FOR THE USE OF**
