RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO ACCEL PRIME TECHNOLOGIES, INC. WHEREAS, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

WHEREAS, this committee previously resolved last 29 July 2021 to declare the submitted bid of APTI in the amount of Two Million Six Hundred Eighty Eight Thousand Pesos (Php 2,688,000.00) as the Lowest Calculated Bid for the Lot 2 of the subject procurement with an approved budget for the contract amounting to Three Million Six Hundred Three Thousand and Three Hundred Pesos (Php 3,603,300.00); and to direct the PBAC Technical Working Group to verify the authenticity and validity of the bid documents submitted by the bidder for purposes of post-qualification and report their findings to the PBAC.


