For qualification, please submit the following set of bidding requirements/documents to the PAO Bids and Awards Committee (PBAC) Secretariat:

A. SET OF BIDDING REQUIREMENTS/DOCUMENTS:

1. Company profile;
2. List of existing and previous clients;
3. Certification from the manufacturer that the bidder is an authorized seller/re-seller/distributor/dealer of the above items;
4. Security and Exchange Commission registration or Department of Trade and Industry business permit;
5. Valid and current Mayor's permit or business permit;
6. VAT registration;
7. Latest Income Tax Return;
8. Audited Financial Statements for Year 2019 (stamped "received" by the BIR);
9. Statement of the prospective bidder that he/she is not "blacklisted" or barred from bidding by the government or any of its agencies/offices;
10. Sworn Affidavit that the bidder or any officer of their corporation is not related to the Head of the Procuring Entity by consanguinity or affinity up to the third civil degree;
11. Sworn Statement by the Head of the Company or authorized representative that each of the documents submitted in satisfaction of the bidding requirements is an authentic copy of the original and all information provided therein are true and correct;
12. Certificate of Registration from *PHILGEPS*;
13. Bid Price;
14. Bid Security in accordance with RA 9184 and its implementing rules and regulations.


B. INSTRUCTIONS TO BIDDERS:

1. Two (2) separate bid envelopes, with two (2) copies each, shall be submitted. The first envelope containing the technical component: the set of bidding requirements/documents; and the second envelope containing the financial component: the bid price and bid security;
2. The bidder shall mark the two (2) envelopes: "**DO NOT OPEN BEFORE 24 March 2021, 10:30 A.M. WEDNESDAY**"; and
3. Both envelopes shall then be sealed and placed in another outer envelope (shall be sealed also) which shall be addressed to the Chairman of the **PBAC**.

C. TERMS AND CONDITIONS:

1. Deadline of submission of bid documents shall be on 23 March 2021, 5:00 P.M. Sealed bids shall be opened during the meeting of the PBAC at the office of PAO-Library, 5/F, PAO-Central Office, at 10:30 A.M. on 24 March 2021 WEDNESDAY. Bidders are requested to be present at the venue and time of the opening bids.
2. Bidders shall be notified of the result of the Bid Evaluation.
3. The Lowest Calculated Responsive Bid/Highest Rated Responsive Bid shall undergo post-qualification process.
