### RESOLUTION

RECOMMENDING THE CANCELLATION OF THE PROCUREMENT, THROUGH SHOPPING UNDER SEC. 52.1b, OF 4,000 REAMS OF COPY PAPER (A4 210mm x 297mm, 80gsm), AS SPECIFIED IN PURCHASE REQUEST NO. 460-05-2023, FOR THE PUBLIC ATTORNEY'S OFFICE FOR FY 2023

**WHEREAS**, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

WHEREAS, this committee previously resolved<sup>1</sup> to recommend the conduct of procurement through Shopping under Sec. 52.1(b) of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. (RA) 9184;

**WHEREAS**, there was an approved budget for the contract of the subject procurement with a total amount of Seven Hundred Eighty Thousand Pesos (Php 780,000.00)<sup>2</sup>;

WHEREAS, this committee previously resolved last 22 June 2023 to award the contract for the subject procurement to the lowest quotation received from supplier CP Par-Lay International Corp. (CP PARLAY);

WHEREAS, CP PARLAY sent a letter last 14 July 2023 informing this Office of its inability to supply the subject procurement due to it being out of stock from its suppliers;

WHEREAS, after consultation with the PAO-Supply Section and the Technical Working Group, it was confirmed that the supply for the subject procurement can be sourced from the expected availability of A4 papers from the Procurement Service of the Department and Budget and Management (PS-DBM) by the end of July 2023;

**WHEREAS**, in line with the declared policy of RA 9184 in promoting good governance by adhering with principles of transparency, accountability, equity, efficiency and economy, it appears that sourcing the subject procurement from PS-DBM may be more beneficial, timely, economical and transparent mode of procurement for this specific need of this Office;

**WHEREAS**, considering the foregoing, BAC Member Dir. Marilyn Boongaling moved to recommend the cancellation of the subject procurement and to commit its procurement instead to PS-DBM, duly seconded by BAC Member Atty. Ronald Macorol;

### RESOLUTION

RECOMMENDING THE PROCUREMENT OF 4,000 REAMS OF COPY PAPER (A4 210mm x 297mm, 80gsm), AS SPECIFIED IN PURCHASE REQUEST NO. 460-05-2023 THROUGH SHOPPING UNDER SECTION 52.1b IN RELATION TO ANNEX "H," NO. V, SUBSECTION (C)1-b OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT NO. (RA) 9184 FOR THE USE OF THE PUBLIC ATTORNEY'S OFFICE – CENTRAL OFFICE SUPPLY SECTION

**WHEREAS**, the Public Attorney's Office (PAO) is committed to adhere to its mandate to represent, free of charge, indigents, and other persons qualified for legal assistance in all civil, criminal, labor, administrative and other quasi-judicial cases where, after due evaluation, it is determined that the interest of justice will be served thereby<sup>1</sup>;

**WHEREAS,** the PAO Central Office Supply Section is in need of the supply for the aforementioned item to ensure unhampered performance of its duties and to prevent delays in its daily transactions,

**WHEREAS**, there is an approved budget for the contract of the subject procurement with a total amount of Seven Hundred Eighty Thousand Pesos (Php 780,000.00)<sup>2</sup>;

**WHEREAS,** considering that the procurement through the DBM-PS is not feasible in view of the unavailability of their supplies, there is thus a need for the immediate purchase of the aforementioned item;

**WHEREAS,** since the pursuit of a competitive bidding will result in the award of the contract relative to the purchase of the mentioned items, only after the lapse of one hundred twenty (120) days from the start of the procurement process, and which period, may not be responsive to the immediate need of the Office;

WHEREAS, considering the aforementioned facts, BAC Member Dir. Marilyn Boongaling moved for the procurement of subject items through Shopping under Section 52.1b in relation to annex "H" No. V Subsection (C)1-b of the IRR of RA 9184, and the said motion was seconded by BAC Member Atty. Alem Abeya;
