RESOLUTION

RECOMMENDING THE PROCUREMENT THROUGH DIRECT CONTRACTING OF FORTY (40) UNITS OF COPIER TONER AND TWENTY (20) UNITS OF COPIER DRUM (COPIER MODEL: BIZHUB 160) UNDER PURCHASE REQUEST NO. 546-07-2019 FOR THE USE OF PAO-SUPPLY SECTION, UNDER SECTION 50(c) IN RELATION TO ANNEX "H," NO. V, SUBSECTION (A)1-c OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT NO. (RA) 9184

WHEREAS, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

WHEREAS, considering that the use of photocopiers and its corresponding parts is crucial in the day-to-day discharge of functions in this Office in view of the voluminous cases it handles both in the judicial and non-judicial services it caters;

WHEREAS, in view of the fact that the copiers of the requesting district office is in need of replacement parts and must all be immediately repaired in order not to hamper the service delivery of the Office;

WHEREAS, since the parts needed to be replaced/repared are exclusively provided by U-BIX Corporation (U-BIX) and the needed parts are critical components of the copiers, it is but proper that the same be immediately procured from the said entity;

WHEREAS, there is an approved budget for the contract of the subject procurement with a total amount of Two Hundred Two Thousand and Sixty Pesos (P202,060.00)¹;

WHEREAS, ultimately considering that the procurement of the mentioned items and the needed services for their installation are critical components exclusively supplied by U-BIX CORPORATION, BAC Member Atty. Ronald Jerome Nieves moved that the practicality and necessity in procuring the same through Direct Contracting in accordance with Section 50(c) in relation to ANNEX "H," NO. V, SUBSECTION (A)1-c of the IRR of RA 9184 is thus in order, duly seconded by BAC Member Atty. Marilyn Balbin;
