R E S O L U T I O N

DECLARING THE RESULT OF THE EVALUATION OF THE SUBMITTED QUOTATIONS FOR THE PROCUREMENT OF BUILDING MAINTENANCE MATERIALS AS SPECIFIED UNDER PURCHASE REQUEST NO. 660-06-2018 AND ORDERING THE SUBMISSION OF DOCUMENTARY REQUIREMENTS FOR POST-QUALIFICATION PROCESSING

WHEREAS, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

WHEREAS, during today's scheduled opening and evaluation of submitted quotations for the subject procurement, the committee received two quotations from **R.E.R CIS** and **MG Trinidad**;

WHEREAS, upon the committee's evaluation of the submitted quotation, it was observed that using the criteria of completeness of bid under Sec. 32.2.1(a) of RA 9184, the quotation submitted by MG Trinidad was incomplete considering that it only contained seven (7) out of the nine (9) items of the subject of procurement;

WHEREAS, considering the incomplete quotation of MG Trinidad, its quotation shall be considered as a non-responsive resulting to a disqualified quotation;


WHEREAS, the submitted quotation of R.E.R. CIS is observed to be responsive, complete and with a total price of quotation that is below the ABC of the subject procurement;

WHEREAS, in accordance with Section 36(b) of RA 9184, it appears that R.E.R. CIS is the Single Rated and Responsive Bid for the subject procurement and is now subject of a post-qualification check;


NOW THEREFORE, WE, the Members of the PAO Bids and Awards Committee (PBAC), by virtue of the powers vested on Us by Law, after duly considering the recommendations of the Technical Working Group (TWG), and all members here present, including The Secretariat, **hereby resolve to declare the submitted quotation of R.E.R. CIS as the Single Rated and Responsive Bid Submission and requiring the R.E.R. CIS to submit to this committee within five (5) days from receipt hereof the following documents for post-qualification check in accordance with RA 9184:**

- a. **SEC/DTI Registration;**
- b. **Business/Mayor's Permit;**
- c. **BIR Registration Certificate;**
- d. **Tax Clearance;**
- e. **Omnibus Sworn Statement**






