RESOLUTION

RECOMMENDING THE PROCUREMENT OF OFFICE FURNITURE SPECIFIED UNDER CONSOLIDATED PURCHASE REQUEST NO. 812-07-2018 FOR THE USE OF PUBLIC ATTORNEY'S OFFICE-CENTRAL OFFICE AND DISTRICT OFFICES THROUGH SMALL VALUE PROCUREMENT (SVP) UNDER SECTION 53.9 IN RELATION TO ANNEX "H," NO. V, SUBSECTION (D)8-a OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT NO. (RA) 9184

WHEREAS, the Public Attorney's Office (PAO) is committed to adhere to its mandate to represent, free of charge, indigents, and other persons qualified for legal assistance in all civil, criminal, labor, administrative and other quasi-judicial cases where, after due evaluation, it is determined that the interest of justice will be served thereby¹;

WHEREAS, considering that the need to maintain an efficient and orderly working environment conducive to promote productivity and professionalism of PAO lawyers and employees is crucial in the proper delivery of the Office's services and the discharge of its mandate;

WHEREAS, the identified end-users in the PAO-Central Office and District Office submitted to the PBAC a request for small value procurement of office furniture as specified in the consolidated Purchase Request no. 812-07-2018 for the use of the PAO- Central Office and District Office, in compliance with the IRR of RA 9184 ;

WHEREAS, considering that subject office furniture items in purchase request no. 812-07-2018 are not listed among the items available in the DBM-PS, and the current need of the Office for the item is necessary for the discharge its daily mandate;

WHEREAS, considering that the pursuit of a competitive bidding relative to the procurement of the same shall likely be concluded only after the lapse of one hundred twenty (120) days, which period, may no longer be responsive to the immediate need of the Office;

WHEREAS, ultimately considering that the purchase of the mentioned items contemplates a purchase of things NOT considered as "ordinary or regular office



supplies," not available in the DBM-PS, and hence not an item susceptible for shopping, the practicality and necessity in procuring the same in accordance with ANNEX "H," NO. V, SUBSECTION (D)8-a, of the Revised IRR of R.A. 9184 is thus in order.





V, SUBSECTION (D)8-a OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT NO. (RA) 9184, in purchasing the OFFICE FURNITURES as described in PURCHASE REQUEST NO. 812-07-2018, for the use of the Public Attorney's Office – Central Office and District Offices.**




