RECOMMENDING THE PROCUREMENT THROUGH DIRECT CONTRACTING OF PARTS AND SERVICES FOR PHOTOCOPIERS USED BY THE PAO-IMUS D.O., SAN FERNANDO D.O., PAMPANGA D.O., AND JOLO D.O. OF THE PUBLIC ATTORNEY'S OFFICE UNDER SECTION 50(b) IN RELATION TO ANNEX "H," NO. V, SUBSECTION (A)1-c OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT NO. (RA) 9184

WHEREAS, the Public Attorney's Office (PAO) is committed to adhere to its mandate to represent, free of charge, indigents, and other persons qualified for legal assistance in all civil, criminal, labor, administrative and other quasi-judicial cases where, after due evaluation, it is determined that the interest of justice will be served thereby¹;

WHEREAS, considering that the use of photocopiers is crucial in the day-to-day discharge of functions in this Office in view of the voluminous cases it handles both in the judicial and non-judicial services it caters;

WHEREAS, in view of the fact that the copiers in the mentioned district offices have are in need of replacement parts and must all be immediately repaired in order not to hamper the service delivery of the Offices;

WHEREAS, since the parts needed to be replaced/repared in the pertinent District Offices, as stated below is exclusively provided by U-BIX Corporation, the procurement of the needed parts is best vested in the said entity, immediately;
