**WHEREAS**, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

**WHEREAS**, this committee previously resolved last 05 November 2019 to declare the submitted bid of M&M Water Refilling Station (M&M) as the Single Calculated/Rated and Responsive Bid for the procurement of Supply and Delivery of Drinking Water for CY 2020 and to direct the PBAC technical working group to verify the authenticity and validity of the bid documents submitted by M&M for purposes of post-qualification and report their findings in this scheduled PBAC meeting.
