RESOLUTION

DECLARING A FAILURE TO OBTAIN A RESPONSIVE QUOTATION IN THE PROCUREMENT OF CONTINUOUS FORM, AS SPECIFIED IN PURCHASE REQUEST NO. 833-07-18 THROUGH SHOPPING UNDER SECTION 52.1b IN RELATION TO ANNEX "H," NO. V, SUBSECTION (C)1-b OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT NO. (RA) 9184 FOR THE USE OF THE PUBLIC ATTORNEY'S OFFICE – CASH SECTION, ADMINISTRATIVE SERVICE

WHEREAS, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

WHEREAS, this committee previously resolved¹ to recommend the pursuance of the procurement of the aforementioned continuous form thru shopping and thereafter issued a request for quotation (RFQ) for the subject procurement;

WHEREAS, after evaluation of the three quotations² received after the previously issued RFQ, it appears that all three submitted quotations exceeded Twenty One Thousand Four Hundred Pesos (P21,400) as the approved budget for the contract as stated in the RFQ, thereby disqualifying all three received quotations for being unresponsive to the stated approved budget limit;

WHEREAS, considering the foregoing, BAC Member Atty. Demiteer Huerta moved to declare the disqualification of the submitted quotations for being in excess of the approved budget for the contract and thereby declare a failure of quotation for the subject procurement, duly seconded by BAC Member Atty. Mariel Baja;

NOW THEREFORE, WE, the Members of the PAO Bids and Awards Committee (PBAC), by virtue of the powers vested on Us by Law, after duly considering the recommendations of the Technical Working Group (TWG), and all members here present, **hereby resolve to DECLARE A FAILURE TO RECEIVE RESPONSIVE QUOTATION FOR THE PROCUREMENT OF CONTINUOUS FORM AS SPECIFIED IN PURCHASE REQUEST NO. 833-07-2018, AND TO CONDUCT A MANDATORY REVIEW AND EVALUATION OF THE TERMS, CONDITIONS, COST ESTIMATES AND SPECIFICATIONS OF THE SUBJECT PROCUREMENT BY DIRECTING THE TECHNICAL WORKING GROUP (TWG) TO ADVISE THIS**
