RESOLUTION

RECOMMENDING THE PROCUREMENT OF MOTOR COMPRESSOR AS SPECIFIED UNDER PURCHASE REQUEST NO. 936-08-2018 FOR THE USE OF PUBLIC ATTORNEY'S OFFICE-LEGAL RESEARCH SERVICE, THROUGH SMALL VALUE PROCUREMENT (SVP) UNDER SECTION 53.9 IN RELATION TO ANNEX "H," NO. V, SUBSECTION (D)8-a OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT NO. (RA) 9184

WHEREAS, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

WHEREAS, to guarantee and ensure effective service delivery, and in view of the humid and high office temperatures, the PAO makes sure that its Offices are well ventilated for its clients and employees through the use of an air-conditioning unit;

WHEREAS, the PAO-Legal Research Service (LRS) submitted to the PBAC a request¹ for small value procurement of an air-con motor compressor specified in purchase request no. 936-08-18 for the use of PAO-LRS Library;

WHEREAS, there is an approved budget for the contract of the procurement of the subject motor compressor with a total amount of Eighteen Thousand E Pesos (P18,000.00)².

WHEREAS, considering that the pursuit of a competitive bidding relative to the procurement of the same shall likely be concluded only after the lapse of one hundred twenty (120) days, which period, may no longer be responsive to the immediate need of the Office;

WHEREAS, ultimately considering that the purchase of the mentioned item contemplates a purchase of things NOT considered as "ordinary or regular office supplies," not available in the DBM-PS, and hence not an item susceptible for shopping, the practicality and necessity in procuring the same in under Section 53.9 in accordance with ANNEX "H," NO. V, SUBSECTION (D)8-a, of the Revised IRR of R.A. 9184 is thus in order;
