RESOLUTION

RECOMMENDING THE PROCUREMENT OF REPLACEMENT TIRES FOR THE USE OF PUBLIC ATTORNEY'S OFFICE-CENTRAL OFFICE, AS SPECIFIED UNDER PURCHASE REQUEST NO. 1178-09-2018, THROUGH SMALL VALUE PROCUREMENT (SVP) UNDER SECTION 53.9 IN RELATION TO ANNEX "H," NO. V, SUBSECTION (D)8-a OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT NO. (RA) 9184

WHEREAS, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

WHEREAS, there is a need to replace the tires of the service vehicles of PAO-Central Office as certified by the PAO-Administrative Service, General Services Section¹;

WHEREAS, to ensure the safety and proper use the service vehicles of PAO, the immediate replacement of its tires is imperative;

WHEREAS, the PAO-Administrative Service Head submitted to the PBAC a request for small value procurement of the subject replacement tires, in compliance with the IRR of RA 9184;

WHEREAS, there is an approved budget for the contract of the subject procurement with a the total amount Two Hundred Fifteen Thousand Eight Hundred Pesos (P215,800.00)²;

WHEREAS, considering that the pursuit of a competitive bidding relative to the procurement of the same shall likely be concluded only after the lapse of one hundred twenty (120) days, which period, may no longer be responsive to the immediate need of the Office;

WHEREAS, ultimately considering that the purchase of the mentioned item contemplates a purchase of things NOT considered as "ordinary or regular office supplies," not available in the DBM-PS, and hence not an item susceptible for shopping, the practicality and necessity in procuring the same in accordance with




ANNEX "H," NO. V, SUBSECTION (D)8-a, of the Revised IRR of R.A. 9184 is thus in order.





(RA) 9184, in purchasing REPLACEMENT TIRES OF PAO SERVICE VEHICLES, AS SPECIFIED UNDER PURCHASE REQUEST NO. 1178-09-2018**, for the use of PAO-Central Office. 


