EXCERPTS FROM THE MINUTES OF THE MEETING OF THE PAO BIDS AND AWARDS COMMITTEE (PBAC) DATED 16 NOVEMBER 2018 RE: CONSIDERATION OF PURCHASE REQUEST FOR THE PROCUREMENT OF CANON FIXING ASSEMBLY UNDER PURCHASE REQUEST NO. 1082-09-2018, AT THE SERVICE HEAD'S OFFICE, FIELD OPERATIONS AND STATISTICS SERVICE (FOSS), PAO CENTRAL OFFICE

RESOLUTION

RECOMMENDING THE PROCUREMENT THROUGH DIRECT CONTRACTING OF TWO (2) CANON FIXING ASSEMBLY SPECIFIED UNDER PURCHASE REQUEST NO. 1082-09-2018 FOR THE USE OF PAO-BUTUAN CITY DISTRICT OFFICE, UNDER SECTION 50(b) IN RELATION TO ANNEX "H," NO. V, SUBSECTION (A)1-c OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT NO. (RA) 9184

WHEREAS, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

WHEREAS, considering that the use of photocopiers and its corresponding parts is crucial in the day-to-day discharge of functions in this Office in view of the voluminous cases it handles both in the judicial and non-judicial services it caters;

WHEREAS, in view of the fact that the copiers of the requesting district offices are in need of replacement parts and must all be immediately repaired in order not to hamper the service delivery of the Offices;

WHEREAS, since the parts needed to be replaced/repared in the pertinent District Offices, are exclusively distributed by Canon thru the Value Systems Inc. (VSI), the procurement of the needed parts is best vested in the said entity, immediately;

WHEREAS, there is an approved budget for the contract of the subject procurement with a the total amount Forty One Thousand Three Hundred Sixty Pesos (41,360.00)¹;

WHEREAS, since the pursuit of a competitive bidding will result in the award of the contract relative to the purchase of the mentioned items, only after atleast one hundred twenty (120) days from the start of the procurement process, and which period, may not be responsive to the immediate need of the Office;

WHEREAS, ultimately considering that the procurement of the mentioned items and the needed services for their installation are critical components exclusively supplied by Canon, BAC Member Atty. Marilyn Balbin moved that the practicality and necessity in procuring the same through Direct Contracting in accordance with Section 50(c) in relation to ANNEX "H," NO. V, SUBSECTION (A)1-c of the IRR of RA 9184 is thus in order, duly seconded by BAC Member Atty. Ronald Jerome Nieves;
