RESOLUTION

RECOMMENDING THE PROCUREMENT THROUGH DIRECT CONTRACTING OF VARIOUS LAW BOOKS FROM CENTRAL BOOK SUPPLY INC., UNDER PURCHASE REQUEST NO. 864-10-2019 FOR THE USE OF PAO-CENTRAL OFFICE, LRS/LIBRARY, UNDER SECTION 50(c) IN RELATION TO ANNEX "H," NO. V, SUBSECTION (A)1-c OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT NO. (RA) 9184.

WHEREAS, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

WHEREAS, the use of updated law books as reference is crucial in the day-to-day discharge of functions in this Office in view of the voluminous cases it handles both in the judicial and non-judicial services it caters;

WHEREAS, since the subject procurement of various law books are exclusively distributed by Central Book Supply Inc. (Central), the procurement of the needed law books is best vested in the said entity, immediately;

WHEREAS, there is an approved budget for the contract of the subject procurement with a the total amount of One Hundred One Thousand Three Hundred Eighty Pesos (P101,380.00)¹;

WHEREAS, ultimately considering that the procurement of the mentioned items are exclusively distributed by Central as evidenced by their Certificate of Exclusive Distributorship, BAC Member Atty. Marilyn Balbin moved that the practicality and necessity in procuring the same through Direct Contracting through Central, in accordance with Section 50(c) in relation to ANNEX "H," NO. V, SUBSECTION (A)1-c of the IRR of RA 9184 is thus in order, duly seconded by BAC Member Atty. Flordeliza Merelos;

NOW THEREFORE, WE, the Members of the PAO Bids and Awards Committee (PBAC), by virtue of the powers vested on Us by Law, after duly considering the recommendations of the Technical Working Group (TWG), and all members here present, **hereby resolve to recommend to the Head of Procuring Entity the adoption of DIRECT CONTRACTING UNDER SECTION 50(c) IN RELATION TO V.A.1.c of ANNEX OF THE IRR OF RA 9184, in purchasing from REX the exigently needed VARIOUS LAW BOOKS FROM CENTRAL BOOK SUPPLY**
