**RESOLUTION**

**RECOMMENDING THE PROCUREMENT OF FOUR HUNDRED TEN (410) PIECES OF WHITE COTTON T-SHIRTS AS SPECIFIED UNDER PURCHASE REQUEST NO. 926-08-2018 FOR THE USE OF PUBLIC ATTORNEY'S HUMAN RESOURCE MANAGEMENT DEVELOPMENT DIVISION (HRMDD), ADMINISTRATIVE SERVICE, THROUGH SMALL VALUE PROCUREMENT (SVP) UNDER SECTION 53.9 IN RELATION TO ANNEX "H," NO. V, SUBSECTION (D)8-a OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT NO. (RA) 9184**

**WHEREAS**, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

**WHEREAS**, in response and in preparation to the invitation<sup>1</sup> sent by the Civil Service Commission-NCR to PAO for their 2018 R.A.C.E. to Serve Fun Run on 02 September 2018, the Chief Public Attorney thru the PAO-HRMDD deemed it necessary to provide free uniform attire for PAO employees participating in the said event;

**WHEREAS**, the PAO-HRMDD, Administrative Service, in compliance with the IRR of RA 9184; submitted to the PBAC a request for small value procurement of Four Hundred Ten Pieces (410) of White Round Neck Cotton T-Shirts for the aforementioned event;

**WHEREAS**, there is an approved budget for the contract of procurement of four hundred ten (410) pieces of the subject t-shirts with a the total amount Pesos: Forty One Thousand Pesos (P41,000.00)<sup>2</sup>

**WHEREAS**, considering that the pursuit of a competitive bidding relative to the procurement of the same shall likely be concluded only after the lapse of one hundred twenty (120) days, which period, may no longer be responsive to the immediate need of the Office;

**WHEREAS**, ultimately considering that the purchase of the mentioned item contemplates a purchase of things NOT considered as "ordinary or regular office supplies," not available in the DBM-PS, and hence not an item susceptible for shopping, the practicality and necessity in procuring the same in accordance with
