EXCERPTS FROM THE MINUTES OF THE MEETING OF THE PAO BIDS AND AWARDS COMMITTEE (PBAC) DATED 20 AUGUST 2018 **RE: RECONSIDERATION OF THE PREVIOUS DISQUALIFICATION OF QUOTATION OF MG TRINIDAD AND RECOMMENDING AWARD OF CONTRACT TO IT FOR THE PROCUREMENT OF BUILDING MAINTENANCE MATERIALS UNDER PURCHASE REQUEST NO. 660-06-2018 FOR THE USE OF PUBLIC ATTORNEY'S OFFICE-CENTRAL OFFICE, AT THE SERVICE HEAD'S OFFICE, FIELD OPERATIONS AND STATISTICS SERVICE (FOSS), PAO CENTRAL OFFICE**

RESOLUTION

RECONSIDERATION OF THE PREVIOUS DISQUALIFICATION OF QUOTATION OF MG TRINIDAD (MG) AND RECOMMENDING AWARD OF CONTRACT TO MG FOR THE PROCUREMENT OF BUILDING MAINTENANCE MATERIALS UNDER PURCHASE REQUEST NO. 660-06-2018.

WHEREAS, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

WHEREAS, this committee previously received two quotations for the subject procurement from R.E.R. CIS (R.E.R.) and MG Trinidad (*MG*);

WHEREAS, this committee previously resolved¹ to consider as unresponsive the submitted quotation of *MG* for being incomplete while declaring the submitted quotation of R.E.R. as the Single Rated and Responsive Bid Submission and required the latter supplier to submit to this committee the required eligibility documents for post-qualification in accordance with RA 9184;

WHEREAS, R.E.R. was unwilling to comply with the submission of eligibility requirements and therefore failed post-qualification leading to its disqualification² as resolved by this committee;

WHEREAS, the PBAC thru the Technical Working Group (TWG) was able to confirm that *MG* has new materials updated and available that are responsive to the subject procurement;

WHEREAS, considering the foregoing, BAC Member Atty. Mariel Baja moved to reconsider the previous disqualification of quotation of *MG* and recommend the award of contract for the subject procurement thru Small Value Procurement (SVP) to *MG* for having the single calculated and responsive quotation, duly seconded by BAC Member Atty. Demiteer Huerta;
